What is HDLI?

What Resources Does HDLI Offer?

HDLI also acts on a national level to influence the development of statutory, regulatory and case law helpful to industry stakeholders.

HDLI List Serve

Via e-mail, List Serve members can instantly post questions or concerns relating to housing finance, management, Section 8, or any other issue of interest, to other List Serve members, and can get instant responses. Or, members simply monitor the exchange of information and perspectives at their leisure.

Amicus Curiae Appearances

HDLI assists its members by appearing as *amicus* in appropriate legal cases, subject to approval by HDLI's Board of Directors. Notably, HDLI was *amicus* to the United States Supreme Court in *Virginia v. Hicks* and *HUD v. Rucker*.

Legal Education Conferences

HDLI holds regular Continuing Legal Education conferences addressing pressing legal topics relevant to housing agencies, hosted in-person or virtually. At each conference, HDLI assembles prominent speakers and provides detailed resource materials. Annual HDLI conferences include the General Counsel Forum, Spring Conference, Commissioners and E.D. Conference, and Fall Conference. HDLI members receive significant discounts on all conference registration fees.

Legal Consultation

HDLI is available to help housing officials and their legal counsel in a consultative capacity, as well as putting members in touch with other members, housing officials, or government representatives who can help resolve their issues.
